Voluntary contributions to MTA/NJ PAC must be paid by check. The MTA/NJ PAC cannot accept cash. A completed MTA/NJ PAC contribution form must accompany each contribution made. Most individuals and corporations in New Jersey can make political contributions. What is the MTA/NJ Political Action Committee?

The MTA/NJ PAC is a non-partisan, non-profit, political action committee formed to raise voluntary contributions for supporting candidates in state and local elective offices who share boating concerns and are sensitive to expanding the recreational boating business and opportunities for growth.

What is the purpose of MTA/NJ PAC?

It ensures members the opportunity to participate in the election and support of candidates who make decisions affecting marine related businesses and the New Jersey recreational boating industry.

Who decides how PAC Funds are spent?

The MTA/NJ PAC is made up of MTA/NJ members who, as recreational boating industry employers, have the same concerns as you do. The PAC decides which candidates to support based on input from MTA/NJ members, voting records on key issues, interviews and recommendations from the MTA/NJ lobbyist and Board of Directors.

The Criteria that the MTA/NJ PAC uses for supporting candidates are: (1) candidates who have consistently supported the MTA/NJ, (2) candidates who are supportive of a strong business climate where the recreational boating industry can grow and prosper.
